
The last five years showed that the Mediterranean region is more dynamic than ever. The political and economic changes experienced by the countries of the basin demonstrated the necessity of a constant adaptation on the path to shared prosperity and mutual understanding between societies. Every summer since 2014 has witnessed an increase in the number of refugees and migrants risking their lives to cross the Mediterranean Sea. This increase in migration is having a wide-ranging impact on countries of origin, transit, and destination, creating new and complex challenges for governments, humanitarian agencies, the European Union, and the international community at large.

It is more obvious than ever that these challenges cannot be simply confronted through national solutions or domestic policies. The need of common policy strategies by multiple actors is becoming an imperative. Therefore, one key to success lies in the improvement of the mechanisms of dialogue, cooperation and integration between all actors. In order to contribute to the interests and the values shared by the countries of the Dialogue 5+5, the MedThink 5+5 network has the main objective of fostering and encouraging inclusive processes of study and dissemination of the causes and the solutions to the main challenges in the Western Mediterranean by gathering representatives of governments, academics, research institutes, and civil society.

In this context, this workshop organized by the European Institute of the Mediterranean, the Institute for International Political Studies and the MedThink 5+5 network, with the support of the Secretariat of the Union for the Mediterranean, will become an excellent opportunity to share knowledge and ideas, while encouraging a better cooperation by associating leading experts to discuss about the management of migration and refugee flows; from the role that metropolitan cities play in this process to the urgent need of establishing legal and safe avenues for refugees and migrants to enter the EU, which could help significantly reduce the size of irregular mixed migratory movements to Europe.
